# LB977 Language Revised

### **Electrical Bill Funding Now Distinctive to Falls City**

Through an appropriations committee technical clean-up approval and working closely with Senator Slama's office, EDGE was successful

updating LB977 language through AM1172 in LB818 on May 1<sup>st</sup>. The language in the bill now reads: (i) Grants to any city of the second class which with two first class railroads, within fifteen miles of two state borders, and which partners with public power utilities for purposes of expanding electrical system capacities and enhancing redundancy and resilience.
