
#### **Business Appreciation Week**

#### LADP Hosts 2013 Site Selectors Guild

Falls City EDGE participated in a site selectors event, sponsored by the <u>Lincoln Area Development Partnership (LADP)</u>, in May. The event brought five nationally known site selectors to our 13-county Southeast Nebraska region in an effort to market each of our community assets and identify target industry areas.

Falls City had an opportunity to host Jim Renzas, a site selector based out of Irvine, California, on the morning of Monday, May 20<sup>th</sup>. The day started with a city official's forum at City Hall for our Mayor, City Council, County Commissioners and Board of Public Works members. We also toured the community



#### Political Dignitaries Visit Falls City

Falls City EDGE has been busy networking with our state's political officials. In March, Nebraska's Third District Congressman Adrian Smith met with a group of local bankers to discuss tax reform and ways to simplify the tax code. Falls City was only one of his many stops across the district. Congressman Smith co-chairs the Tax Reform Working Group of the House Ways and Means Committee with John Larson of Connecticut.

On April 30<sup>th</sup>, U.S. Senator Deb Fischer stopped in Falls City for a tour of our community as well as a meet and greet with the public. An open house was held at the EDGE office followed by a community tour which included visits to WASP, the CGB construction site and a walk thru Main Street's downtown district. Fischer was impressed with our town noting, "As a rural community, Falls City has much to offer, and your continuous efforts to spur development and preserve business is outstanding."

#### Prime Real Estate Lots FOR SALE



Champion's Crossing subdivision was finalized in May 2013 and this newly platted property, owned by Falls City Industrial Development Corporation, covers approximately 23 acres targeted for new residential development. This area offers the potential construction of 30+ new homes and there are challenges that will need to be met in order to successfully move this housing development project to the next level. A rural community of 4325 people generally has a hard time finding a housing developer to invest in the construction of new homes so EDGE is working to creatively advance the housing goals outlined in the 2010 Falls City Housing

<u>Study</u> using local investors. Our goal for 2013 is to find a group of local investors and begin the construction of 2 new homes. These homes will be located on West 31<sup>st</sup> street next to Wilderness Falls and they will be offered for sale. In addition, there are currently 4 prime real estate lots for sale on 28<sup>th</sup> Street just west of Falls City Healthcare Community. What does the long range plan of this area look like? As lots are sold and homes are built Falls City Industrial Development Corporation, in cooperation with the City Falls City and EDGE, will reinvest funds to pay for the costly infrastructure needed to continue housing development in this area. Falls City wants to see higher value homes being built in order to capture those tax dollars so we have worked hard to provide a great place to build inside the city limits. So, as construction season is upon us now is the time to consider taking that big step and build your own dream home!

EDGE, through its Product Development and Public Policy Committee, supports local, state and federal policies, legislation, funding sources and programming that will enhance the business and regulatory climate for capital investment and job creation, especially those rural in nature and rural initiatives. It is imperative that we keep our economic development priorities at the forefront of our elected officials so we can advance our goals and continue our success. One of EDGE's great successes, the new Missouri River Bridge at Rulo, involved strong collaboration with our public officials as the alliance developed and implemented a focused public policy advocacy agenda, including traveling to Washington DC and Lincoln to meet with leaders, to secure state and federal funding for the new bridge.

EDGE works to develop relationships with legislators charged with creating public policy agenda's that support economic development. It is also important for public officials to see how programs such as the SBA and CDBG programs are working in their communities. These relationships have emboldened our organization and we are pleased with the strong partnerships we've established with our leaders as it is a very important part of the economic development strategy.
