Housing Development Funding Approved

The Falls City City Council last month unanimously approved EXCEL

Development Group's request for \$65,000 in infrastructure funding for a new senior housing development.

Headquartered in Lincoln, EXCEL specializes in senior living communities and affordable housing.

EXCEL has completed more than 800 units, totaling more than \$80 million dollars in development.

The approved funding will be used for water, sewer and street infrastructure. \$60,000 of the approved funding will be provided through Tax Increment Financing, with the additional \$5,000 provided through LB 840 funding.

The development will be called Wilderness Falls. The plan consists of 16 affordable duplexes and 6 market-rate duplexes. "The \$3 million dollar project will help attract retirees to Falls City as well as reduce the flight of current residents to neighboring communities," said Beckie Cromer, EDGE Executive Director.

The Wilderness Falls housing development project is one of the outcomes of the January 2010 Falls City Housing Study completed by Hanna: Keelan Associates, a Lincoln-based professional community and research consulting firm, with guidance and direction from the City of Falls City Housing Board and EDGE. The study provides direction and clarity to improving the housing inventory and enhancing redevelopment efforts in Falls City.

"Available, quality housing is a key factor in Falls City's success in attracting new businesses and attracting and retaining workers at all income levels," said Cromer. "We are working diligently in collaboration with the City to meet the goal of developing up to 82 new housing units by 2015."






Groundbreaking for Missouri River Bridge at Rulo

Nebraska Governor Dave Heineman joined leaders from three states to break ground for the new Missouri River Bridge at Rulo in Richardson County. The Governor credited area residents for their role in a letter-writing campaign that urged government financial support for the new \$32 million dollar bridge.

"We're here because of all of you," the Governor said in his keynote address. "This project is not only significant to our state—but to our neighbors in Kansas and Missouri. The new bridge is critical for economic development and tourism throughout the Nebraska, Kansas and Missouri tri-state region."





Beth Sickel, Co-Chair of the Tri-State Corridor Alliance and President of Falls City EDGE, served as emcee for the program. In addition to remarks by the Governor, NE State Senator Lavon Heidemann; Alan Abbott, Highway Specialist for NE U.S. Senator Ben Nelson; Angela Kreps, aide to MO U.S. Representative Sam Graves; and Brown County (KS) Commissioner Steve Roberts and Mitch Glaeser (Falls City) representing the Corridor Alliance, participated in the program. Sickel also recognized her co-chair, Charlie Radatz, for his leadership and hard work on the project.

"This is a great time to celebrate," said Radatz. "Many hundreds of people from all three states have made this new bridge possible. Because of their involvement, construction is beginning four years sooner than was thought possible when an effort to gain support for a new bridge was launched."

Actual work on the bridge is already under way. The new bridge is being constructed approximately 650 ft. south of the existing bridge. Construction of the 1,026-ft.-long main span started in late August; and the Missouri side approach, including roadway embankment, culverts, concrete pavement and an 883-ft. section of bridge, started last month.

Flat Water Wind Farm on Schedule

The \$145 million dollar wind power project is on schedule according to company officials.

GE turbines began arriving by truck in August. The concrete foundations, each reinforced with massive amounts of rebar, have been poured and erection of the turbines began in September. As of the end of September, the skyline in southwestern Richardson County is patterned with 18 wind turbines as construction continues to progress.

The project, which provides the greatest valuation increase in the history of Richardson County, is employing approximately 140 workers—half of them from the county. Moreover, Gallop Power, the company that is constructing the green energy project, estimates that \$100,000 per day is being spent in the county on everything from salaries to lodging, groceries and fuel.

The wind farm is expected to be operational by January 1. OPPD has agreed to purchase all of the power produced by the 60 megawatt wind farm.

EDGE will host a program on the Flat Water Wind Farm project for Falls City Middle School students on October 19th at 2:00 PM. The public is invited to attend. According to Beckie Cromer, EDGE Executive Director, "The all-school assembly will be a good way to share recent economic development successes with students, as well as educate them on exciting opportunities in the field of renewable energy."

USDA Awards Southeast Nebraska Communications \$11.3M to Expand Broadband

<u>Southeast Nebraska Communications (SNC)</u> received notification in August from the U.S. Department of Agriculture of approved funding assistance for an exciting new project to extend Fiber-to-the-Home (FTTH) technology to over 1,200 rural households and businesses.

According to Beth Sickel, Vice President and General Manager, "This \$11.3 million dollar USDA award, a combination loan and grant, will help provide investment to extend FTTH technology to residents in the villages of Salem, Shubert, Stella, Rulo, Verdon, Barada and Preston, along with all of the surrounding rural areas." SNC is currently in the process of installing FTTH technology to all homes and businesses in Falls City, where upon completion, it will be the largest community in Nebraska to be completely upgraded using this state-of-the-art fiber optic network. Once FTTH technology is extended to rural villages and areas, SNC's service territory will be 100 percent fiber optic.




Sickel who also serves as President of EDGE said, "SNC's progressive vision for the future of providing all households and businesses in its service territory with FTTH technology will help toward stabilizing shrinking population and providing economic growth through innovation, collaboration, and professional development. Now that vision will be a reality!"

Falls City Finalist for Dual Rail Site Planning Grant

EDGE is a finalist in the running for a Community Development Block Grant through the Nebraska Department of Economic Development (NDED) to assist in the site analysis and master site development of a dual rail-served industrial park. According to EDGE Executive Director Beckie Cromer, the detailed application involved extensive coordination and support of the railroads serving Falls City—the BNSF and Union Pacific, the City of Falls City Municipal Utilities, Southeast Nebraska Communications and the land owners.



Next steps in the process involve NDED conducting on-site visits. NDED's announcement of up to five sites to receive planning grant(s) is expected in November.

Governor Heineman Highlights Priorities for Nebraska's Continued Economic Vitality

In September, Governor Dave Heineman outlined the findings of a new report that surveyed Nebraska's business climate and recommended strategies to capitalize on the state's existing resources. "This report provides us with a roadmap for future economic development efforts," Governor Heineman said. "It helps us better understand Nebraska's strengths and competitive advantages. It highlights opportunities for better collaboration and it offers ideas for accelerating new economy innovation in communities across Nebraska."

Three initiatives were identified as key to Nebraska's future competitiveness, including: providing tailored support to encourage development of growing industries in the state; connecting talented professionals and recent graduates with opportunities for high-skills jobs in Nebraska; and supporting the innovative expansion efforts of companies already doing business in the state.



The report indicates that Nebraska is well-positioned for continued growth with an unusually diverse economy. Twelve industry clusters were identified where Nebraska is already a national leader or is well-suited for additional growth. Governor Heineman said, "We are fortunate to have so many industries that are strong and contribute to our economic base. Our challenge for the next few years is to create new opportunities to attract more specialized and advanced companies to Nebraska."

Five industries are strong with businesses providing specialized services and with growth rates outpacing national rates. Industries considered to be current strengths for Nebraska include: the financial services; companies providing transportation, warehousing and distribution logistics services; precision metals manufacturing; bioscience-related firms; and renewable energy. Three industries represent emerging strengths for the state with strong potential to attract new investment and create new jobs. Emerging industries include: research and development and engineering services; health sciences; and hospitality and tourism Four industries provide specialized services to customers and have a significant presence in Nebraska. Companies are considered to be important to retain and would benefit from a highly-trained workforce. Four industries classified as retention priorities for the state include: agriculture and food processing; business management and administrative services; software and computer services; and agriculture machinery.

The comprehensive review was developed with input from state and local economic development professionals, university and college officials, and rural and urban business leaders. The Nebraska Departments of Economic Development and Labor oversaw and funded the study conducted by the Battelle Technology Partnership Practice, the world's largest nonprofit independent research and development organization. EDGE Identifies Target Industries

With assistance from Nebraska Department of Economic Development, EDGE identified three target industry sectors where the Falls City area offers a distinct competitive advantage: advanced manufacturing—wind energy, rail transportation services and business services—customer service call centers and data centers. According to EDGE Executive Beckie Cromer, "These targets build upon recent development successes and are well matched to the area's assets and workforce skills and knowledge."

- Worked with state and federal officials to improve transportation infrastructure, including the new Missouri River Bridge at Rulo
- Improved quality of living infrastructure, including a new hospital, library and recreational amenities
- Collaborating to improve housing options, including initial phases for planning a 27-acre residential development site which include the proposed Excel Development project

These improvements are enabling the Falls City area to compete more frequently and more effectively for public and private investments.
